## **CALL FOR NOMINATIONS**

Delegates of the PSAC Ontario 5<sup>th</sup> Triennial Convention will elect a Regional Executive Vice-President (REVP) and an Alternate Regional Executive Vice-President to serve a three-year term.

### **Nominations: Eligibility for Office**

- Nominations open effective March 29, 2011.
- PSAC members in good standing *who live or work in the Ontario Region* are eligible for nomination to these elected positions.
- PSAC members are not required to be Convention Delegates to be nominated for these elected positions.
- Nominations shall be in writing, signed by a nominator and a seconder, each of whom must be accredited delegates at the 2011 Convention.

### **Nomination Deadline:**

- Nominations from PSAC Ontario 5<sup>th</sup> Triennial Convention delegates will be accepted (1) if received by mail or fax by the Regional Coordinator – Ontario (Christopher Wilson) at the Toronto Regional Office up to and including May 11, 2011 at 5:00pm, or (2) if received by the Chair of the Nominations Committee during Convention or (3) will be accepted from the Convention floor during the election proceedings.
- Nominations from members in good standing that are not delegates at the 2011 Regional Triennial Convention must be received by mail or fax by the Regional Coordinator – Ontario (Christopher Wilson) at the Toronto Regional Office prior to the start of Regional Convention and **no later than May 11, 2011 at 5:00pm**

### **Nominees Address to Convention Delegates:**

- Candidates will be invited to address the Convention Delegates on May 15<sup>th</sup>, 2011 for a maximum of three minutes in the reverse order of nomination.
- Candidates not attending the PSAC Ontario 5<sup>th</sup> Triennial Convention can have a delegate speak on their behalf, or are invited to submit a written statement in advance of the elections that can be read by a member of the Nominations Committee.

### **Submitting the Nomination Form:**

You will find attached as a Nomination Form for the position of Regional Executive Vice-President and Alternate Regional Executive Vice-President.

### **Election Process**

A Nominations Committee will be appointed by the Ontario Regional Council and ratified on the Convention floor. The Chairperson of the Nominations Committee is also appointed by the Regional Council and either they or the ranking PSAC National Officer will conduct the election of REVP and Alternate REVP.
